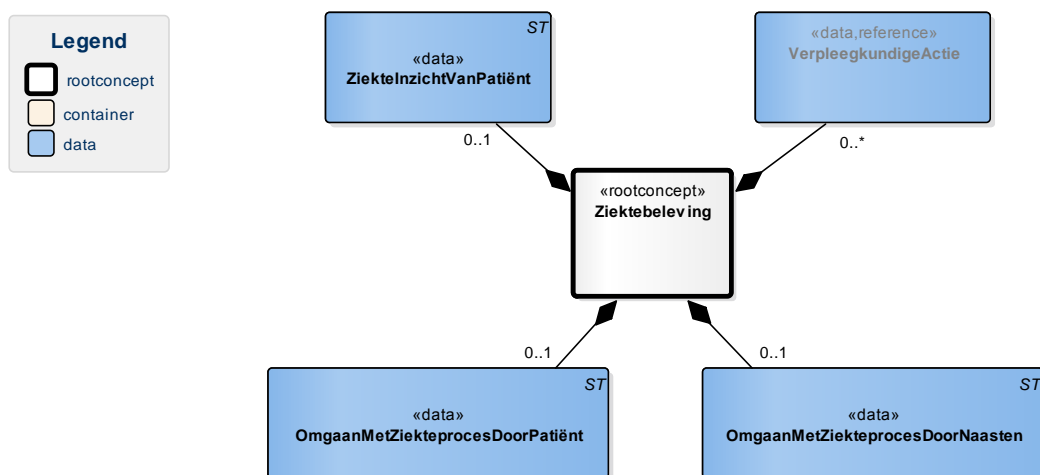
Information on the extent of the insight of the patient and their environment into the consequences of their
