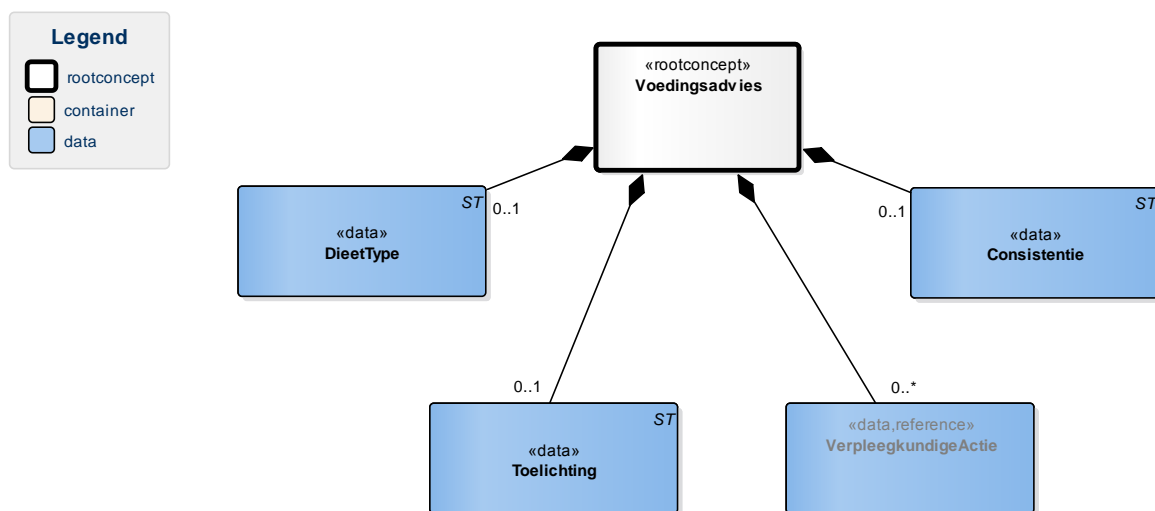
Recording and communicating dietary recommendations provides insight in policy regarding the patient's diet. If this information is not available, it can lead to unsafe situations for the patient.
