1.2 Concept

The Healthcare Results (healthcare results) concept describes the determined status of the patient in terms of a certain problem. Comparing the healthcare result with the treatment goal provides insight into the effectivity of the nursing interventions/activities carried out for this problem. It is a part of the nursing process, together with nursing diagnoses/problems, the treatment goal and nursing interventions. There are different classification systems that describe healthcare results with a measurement value, such as the NOC (Nursing Outcome Classification), Omaha System, and ICF (International Classification of Functioning, Disability and Health). One of these classifications is to be used if possible.

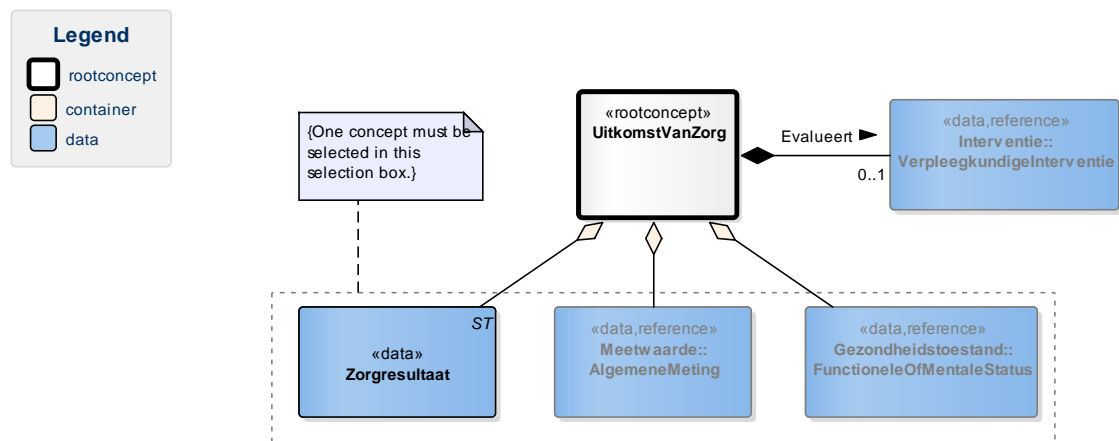
